Becoming a **Certified Green Business** isn't just about doing the right thing—it's about gaining recognition, standing out, and unlocking new opportunities. Here's how this certification benefits you:

- Earn Recognition & Credibility Get officially recognized by Bethesda Green and the Montgomery County Department of Environmental Protection as a sustainability leader.
- Showcase Your Commitment Receive a certificate, window decal, and program logo to proudly display your Green Business Certification to customers, clients, and the community.
- Boost Your Visibility Be featured on Bethesda Green and Montgomery County DEP websites, with a dedicated bio that highlights your sustainability initiatives.
- Amplify Your Marketing Gain access to collaborative marketing efforts, including press releases, social media features, newsletters, and county-wide green business campaigns.
- Connect & Grow Join a community of like-minded businesses through our quarterly Green Business Cohorts, where you can exchange ideas, learn from experts, and strengthen your sustainability practices.





Certified Green Business: A Quick Guide

Your certification journey is divided into 3 steps:

- 1. Getting Started
- 2. Certification
- 3. Recognition and Ongoing Engagement

1. **Getting Started:**

- o Fill out the <u>Preliminary Application</u> to help us understand the nature of your business, gauge your needs and determine the yearly fee based on the size of your business.
- Once submitted, you'll receive an email from our team confirming your submission, providing payment instructions and the document you will use to guide your certification process, track your progress and become certified.
- Depending on the nature of your business we will send you one of three
 Scorecards that you will use to get certified:
 - Office-Based: Designed for businesses operating from a physical workspace, this certification helps you implement sustainable practices in energy use, waste reduction, purchasing, and employee engagement.
 - Fully Remote: Tailored for businesses with no physical office, this
 certification focuses on reducing environmental impact through
 remote work best practices, sustainable home office setups, and
 responsible digital operations.
 - Landscaping/Lawn Care: Built for businesses in outdoor services, this certification emphasizes eco-friendly landscaping techniques, water conservation, pesticide-free practices, and responsible waste management.

Note: If a business doesn't fit into these categories, we will work on a case-by-case basis to help you get certified.

Each office location, whether standalone or within a business park, requires individual certification. If you have multiple locations, each must be certified separately. Only Montgomery County sites are eligible.

Landscaping and fully remote businesses have separate certification



Quick Start Guide

- Certification costs are based on the size of your business, ensuring fairness and accessibility. Pricing is determined by the number of full-time employees, with two part-time employees counting as one full-time equivalent.
- The annual fee covers certification, support, materials, business recognition (website, social media, Ride On bus campaign, etc) and education events.
- Scholarships are available for small businesses needing financial support, serving underprivileged communities, and/or minority/woman owned businesses. If you think your business might qualify, please let us know on the Preliminary Application.

2. **Certification**

- Once your eligibility is confirmed, we'll email your Certification Scorecard to help you track and implement green initiatives. Need guidance? You can schedule an online meeting for support or coaching.
- You'll work on your certification spreadsheet, completing the required Assessment and any
 additional actions you choose. As you implement these, you'll earn points toward
 certification. Once you've met the required actions and reached your desired point level,
 you'll be ready to submit your application to certify—on your timeline and at the tier that best
 reflects your achievements.

Verification and Onsite Visit

- Depending on the nature of your business, scorecard points and the tier you have reached,
 we may conduct an in-person verification to validate the certification.
- The scorecard provides guidance regarding the information you will need to prepare, and have ready to share, to prove implementation of the actions you have checked as completed.
- o If an in person visit **IS** required we will ask you to have the proof of implementation ready at the time of our visit. Generally office-based and landscaping businesses require in-person verification at the Gold or Platinum certification levels, and sometimes at Silver.
- If an in person visit IS NOT required we will ask you to submit proof of implementation online and may set up a call to discuss details. Fully remote businesses usually do not require an inperson visit.
- Office visits typically last around 1.5 hours, with landscaping visits varying based on operations. Duration of visit depends on your organization's size and how easily you can share proof of implementation.
- o After your business is verified we will confirm certification and tier within a week.

3. **Recognition & Engagement:**

Certification Packet

 Once the certification is completed, businesses receive an email confirming the certification level and a program logo indicating the tier of recognition. A physical packet from the Montgomery County Department of Environmental Protection, including a certificate and program decal is mailed later.

Green Business Recognition

- After certifying and submitting a bio for your business, we will add it to <u>Montgomery County's</u>
 <u>Green Business Directory</u>.
- We will also work to showcase your business in partnership with the county. This may include social media posts, <u>Ride On Bus campaigns</u>, etc.

Stay Engaged

- Throughout the year, Bethesda Green will continue to support you in your ongoing sustainability efforts by offering recognition opportunities, educational events to help implement new actions, opportunities to engage with peers in a Green Business Cohort, etc.
- o You will pay an annual fee to stay engaged with the community.
- At any time, you can add new actions you may have implemented and accumulate points to move to higher certification levels. If you do not wish to make any changes your recognition will last for three years.
- After three years, your business will be required to submit a new application to maintain certification. You will be able to utilize your old application and still get credit for the actions you have implemented assuming they are institutionalized and part of your day-to-day operations. However, certain actions by their very nature, such as those that require holding periodic meetings or participating in volunteer events, will have had to occur within the year prior to your re-submission.
